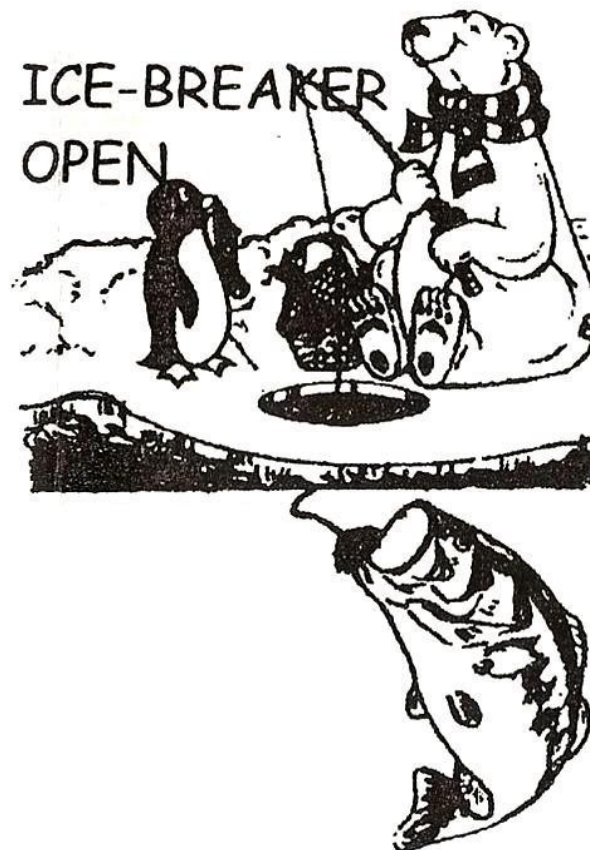

This tournament is in memory of Doug Hanes, a friend and a great fisherman. Doug fished both the Team and Legacy Series of Fishers of Men. He enjoyed fishing with his boys and his friends and rarely missed an event.

The proceeds from this event will be used to support Fishers of Men events.

Entries by mail must be sent in time to reach Director by Thursday prior to the event. Boat positions will be assigned based on the date of the post mark.

Entries will also be accepted at the launch site on Friday evening prior to the tournament between 4:00 and 6:00 p.m. and on tournament day beginning at 5:30 a.m. Boat positions will be assigned as entries are received.

RULES:

1. All boats must start and end at Moundwood Ramp launching area. Other ramps may be used for access. Live-well check will begin at 5:30 AM.
2. Tournament hours are 7:30 AM to 3:30 PM. Flights may be assigned and check-in times will be adjusted accordingly. Late arrivals to weigh-in will be disqualified.
3. There is a five-bass limit per boat. This is a team event; any contestant fishing alone will be considered a "team."
4. All contestants must wear a U.S. Coast Guard approved life vest while gas motor is running.
5. All state and local laws must be observed. Rules violations must be reported to tournament officials before cash prizes are awarded.
6. Horsepower limited to BIA plate ratings.
7. No trolling allowed. Only artificial baits may be used. All fish must be caught in a sportsman-like manner.
8. In case of ties cash awards will be combined and split evenly.
9. All live wells must work properly. A .25 pound penalty will be given for each dead bass.
10. Any bass less than 12 inches brought to the scales will result in a 1 pound penalty.
11. 100,000 Boat liability is required
12. Winners will be required to provide Social security numbers prior to receiving checks.
13. Decisions of the Tournament Directors are final.

Notice: Having acquainted myself with the rules and regulations governing this event, I/we have completed this application and have paid the \$70 entry fee. In signing this application, I/we hereby waive and release all other contestants, the host, sponsors, and tournament officials from all claims or injury related to this tournament. I/we agree there will be a \$100 service fee for a returned check.
